

# **Top Gun Premium Plaster**

A modified, premium blended plaster for conventional stucco systems.

## **Description:**

Top Gun Premium Plaster is a modified, premium blended plaster base coat for conventional stucco systems. Top Gun Premium Plaster is designed to be a pump grade product with excellent flow that does not require additional additives. It may also be applied manually. Top Gun Premium Plaster develops higher PSI strengths than standard Plastic Cement. A fibered version of Top Gun Premium Plaster is also available.

## Packaging:

This product is packaged in 94 lb / 46.63 kg bags.

## Benefits:

- · Excellent flow for pumping.
- Faster mixing cycles than 50/50 mixes of Portland and Plastic Cements.
- · Higher strengths than Plastic cement.

#### Coverage:

Approximate Coverage: 90 sq. ft. / 10 sq. yds. – 99 sq. ft. / 11 sq. yds. at 3/8" thickness.

#### Mixina:

Sand and potable water are required to mix this product. Plaster sand shall comply with ASTM C 144 or C 897. Cement to sand ratio shall comply with ASTM C 926 Table 3. This product shall be mixed in a mechanical type mixer. Add half the potable water and half the sand required for the batch. While sand and water are mixing add all the necessary bags required to complete the mix batch. Add the full amount of sand required and the minimum amount of water to bring the mix to the proper consistency. Allow batch to mix for 3 to 5 minutes after all materials are added.

## Approximate water usage:

1/3 cement to sand – 2 <sup>3</sup>/<sub>4</sub> to 3 <sup>1</sup>/<sub>4</sub> gallons 1/4 cement to sand – 3 <sup>3</sup>/<sub>4</sub> to 4 <sup>1</sup>/<sub>4</sub> gallons

## Application:

This product may be applied by hand or machine. Application methods, acceptable substrates and total applied thickness shall meet the requirements set forth in ASTM C926. This product may be used in a standard scratch and brown application; or by the Alternate Method of Application per IBC Section 2512.8. Alternate Method of Application provides a better bond between coats, improves curing and speeds completion times. Alternate method of application is not suggested for open-frame construction.

## Curing:

This product requires a minimum of fortyeight (48) hours moist curing. Environmental conditions such a heat, wind and low humidity all require liberal curing.

## Finishing:

A variety of finishes such as Western Exterior Stucco, Premium Acrylic Finish (PAF), WBP Exterior Stucco Finishes, standard acrylic paints or elastomeric coatings may be applied over the cured base coat. The recommendations of the finish coat manufacturer shall be followed regarding base coat preparation, bonding, application and curing of their product.

## Limitations:

Do not add accelerator, air entrainment or other admixtures without written permission from an authorized manufacturer of Western Blended Products.

Do not apply when surface or ambient temperatures are at or below 40°F/4.4°C or above 100°F / 34°C. Do not apply to surfaces that are contaminated with bond breakers, oils or other matter that may affect the performance of the product. Do not apply if conditions are expected to be above or below the specified temperature range within 24 hours of application. Do not add additional ingredients without specific written approval from an authorized manufacturer of Western Blended Products.

# Storage:

Product shall be kept indoors or if stored outdoors, shall be adequately covered to keep dry and be stored off the ground.

## Shelf Life:

One year under optimal storage conditions.
